Social School Entrepreneurship (SSE) is an educational program that empowers students to gain practical experience in creating and managing their own projects, often with a social mission. It's more than just a business simulation; it's a real-world opportunity for students to:

- **Develop Entrepreneurial Skills:** From ideation to implementation, including planning, marketing, finance, and management.
- **Address Social Issues:** Many SSE projects are designed to tackle local or global social problems.
- **Work in Teams:** Students learn to collaborate, delegate tasks, and make collective decisions.
- **Gain Hands-on Experience:** Instead of purely theoretical knowledge, they apply it practically, facing real-world challenges.

Key Considerations

- **Non-Profit Orientation:**
 - SSE projects are typically not structured as fully-fledged commercial enterprises. Their primary objectives are educational and social, not profit generation.
 - Consequently, they generally don't fall under the standard tax regimes that apply to commercial companies.
- **Limited Scope of Activity:**
 - SSE projects usually operate within the confines of a school or educational program, with their activities subject to specific rules and timeframes.
 - This limited scope also influences their tax status, as they don't engage in ongoing commercial operations.
- **School Support:**
 - Schools or educational programs often provide SSE projects with resources, facilities, and financial backing.
 - This can mean that project revenues and expenses are accounted for within the school's budget, rather than as a separate legal entity.
 - In such cases, it's essential to consider local tax laws and seek professional advice.
